According to a Reuters poll of economists, India is expected to remain the fastest-growing major economy in FY24, with a projected growth rate of 6.9%, a slight upgrade from the previous poll. While concerns about high inflation persist, economists anticipate a short-term decline, and despite challenges such as private capex and job creation, most economists predict improved employment prospects in the next six months.

Davos 2024: IKEA Looks At India As An Exports Hub, Says Deputy CEO

IKEA is planning to position India as a production hub, aiming to produce not only for the Indian market but also for global exports. Juvencio Maeztu, the deputy CEO and CFO of Ingka Group, which operates IKEA, highlighted the company's commitment to utilizing India for production and sees unique opportunities for growth in both production and sourcing. The move is intended to lower prices by creating more volume through increased production in India, with a focus on harmonizing standards. With an investment exceeding Rs 10,500 crore in India, IKEA plans to open new stores, establish an online store in Delhi, and expand its online presence in states like Andhra Pradesh, Telangana, and Gujarat. The company aims to collaborate closely with the Indian government and enhance its connection with the 2 million-member strong IKEA family in India.

India has emerged as the world's second-largest producer of mobile phones and logged a five-fold increase in mobile phone manufacturing in the last decade, President Droupadi Murmu said on Wednesday, outlining the global acknowledgement of India's prowess in digital transactions and systems. Her first address to a joint sitting of the two Houses in the new Parliament building resonated with references to the rapid expansion of the startup ecosystem, nation's AI push, speedy 5G roll-out, as well as the semiconductor sector investments.

India's electronics exports surpass \$20 billion, iPhone dominates surge

India witnessed a 22.24 per cent surge in electronics exports, surpassing the \$20 billion milestone within the nine months of the financial year 2023-24 (FY24). This was spearheaded by surging smartphone shipments, especially Apple's iPhone, according to a report by The Economic Times (ET). Mobile phone exports, accounting for 52 per cent of total electronics exports, reached \$10.5 billion between April and December 2023. Notably, iPhones emerged as the primary driver of exports, contributing 35 per cent of the total electronics exports and a staggering 70 per cent to the country's overall mobile exports during this period. In December 2023 alone, iPhone exports exceeded \$7 billion.

Boeing's new India Engineering and Technology Centre (BIETC) near Bengaluru was inaugurated by Prime Minister Modi, marking Boeing's largest investment outside the US. Additionally, PM Modi launched the Boeing Sukanya Program, aiming to support women's participation in India's aviation sector through STEM labs, scholarships for women pilots, and support for flight training and career development.
