## SECTION II: TERMS AND CONDITIONS

1. Validity of the Offer: The offer should be valid for 90 days from the - date of opening of Financial Bid; it can be further extended for the period of three months.

2. Bidders are required to deposit Bid Security of USD 1000 (One Thousand only) in the form of Pay Order, Cashier Check in favor of "Consulate General of India, New York". Bids received without Bid Security will not be considered and rejected summarily. Bid Security of all unsuccessful bidders shall be refunded within 30 days of awarding the tender. No interest shall be payable for Bid Security

3. The Tender shall be neatly arranged, plain and intelligible. Each page of the Tender should be signed. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the Tender. The conditional tender will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature.

4. The Bidders shall submit documentary evidence in respect of their technical capabilities and the Financial Bid including their experience in execution of similar nature of work.

5. Any tender received by Office of the Consulate General of India New York, after the deadline for submission of tenders, will not be accepted and returned unopened to the bidder.

6. Interpretation of the clauses in the Tender Document/Contract Document. In case of any ambiguity/ dispute in the interpretation of any of the clauses in this Tender Document, CGI NY' interpretation of the clauses shall be final and binding on all parties.

7. The successful bidder, on award of contract, must send the contract/acceptance in writing, within seven (7) days of award of contract, failing which the EMD will be forfeited and the order will be placed to the next successful bidder. The EMD shall also be forfeited if the bidder withdraws the tender during the period of tender validity specified in the tender.

8. Delivery: The Modular furniture, Storage units and other items should be delivered, placed, installed and commissioned at within a stipulated period of four weeks from date of issue of letter of award.

9. Responsibilities: The specified fixture, fittings and all other items supplied should be brand new furniture. Consulate General of India, New York is not bound to provide any mode of transport in respect of men or material required for the contract.

10. Prices: Price quoted by the Contractor and agreed to by Consulate General of India, New York shall be considered final and no price escalation will be permitted thereafter. Bidders must quote the price in the format given in Contract Price Schedule at Section-V of this document. All prices are to be quoted only in USD.

11. Taxes and Duties: The prices quoted should be inclusive of all taxes and duties, if applicable in New York. VAT should not included as Consulate General of India, New York is exempted from the VAT.

12. Consulate reserves the right to terminate the contract at any point of time during the tenure of contract, if the services are not found satisfactory or the contractor dishonors the contract. Decision of the Consulate in this regard shall be final and binding upon the contractor.
