

NOTICE INVITING e-TENDER
(Under International Competitive Bidding)

Oil and Natural Gas Corporation Limited, Drilling Services, MR, Mumbai invites Open ICB e-tender in **TWO BID SYSTEM** for the following services from experienced Contractors as detailed in the tender document.

1. **e-TENDER No:** P46OC13013.
2. **DESCRIPTION:** Hiring of Cementing Services for 16 Rigs.
3. **TENDER FEES:** Rs. 45,000.00
4. **EMD / Bid Bond:** For India Bidders: Rs. 55,18,000.00 / For Foreign Bidders: USD 131,511.00
5. **TENDER SALE PERIOD:** 12.04.2013 to 02.05.2013.
6. Prospective bidders can purchase the tender document through payment gateway of ONGC e-Procurement website <https://etender.ongc.co.in> using credit cards. In case of any subsequent reversal of credit against credit card payment would lead to rejection of bids submitted by such bidders.

The tender is to be submitted in the ONGC's e-Procurement SRM system. Hard Copies of following documents are to be submitted in the Tender Box of DS, provided in ONGC Office at "11-High" ONGC Office Complex, 3rd Floor, Sion-Bandra Link Road, Sion-West, Mumbai – 400 017, India or in the CENTRAL DAK Section of 11-High, Ground Floor at the above address. Please refer to Cl. No. 19.0 – Sealing & Marking of Bid at Annexure – I; Instruction to the Bidders.

7. The bid along with all appendices and copies of documents (including scanned copies of the documents required in original) should invariably be submitted in the "document area in C-Folder" through ONGC's e-bidding engine portal, before the scheduled date and time for the tender closing. All the documents uploaded shall be digitally signed by the authorized signatory of the bidder.

However, the following documents should be submitted in physical for also, in a sealed envelope superscribed as "Physical documents against e-procurement Tender No. P46OC..... for Hiring of Cementing Services for 16 Rigs, opened on.....", so as to reach to the Purchaser's Office (as indicated in the "invitation to bid") within 7 calendar days, after opening of bids (submitted through the e-bidding portal)

- i. The original bid security.
- ii. The power of attorney or authorization, or any other document consisting of adequate proof of the ability of the signatory to bind the bidder, in original, when the power of attorney is a special "Power of Attorney" relating to the specific tender of ONGC only.

A notarized true copy of the "Power of Attorney" shall also be accepted in lieu of the original, if the power of attorney is a general "Power of Attorney". However, photocopy of such notarized true copy shall not be accepted.
- iii. Integrity Pact duly signed by the authorized person.
- iv. In the cases of Indian bidders claiming Price preference, the original Statutory Auditor Certificate in separate sealed envelope super scribed with tender number and "Statutory Auditor Certificate for price preference" along with a blanked out copy in the technical bid. (Refer detailed clause in BEC in Cl. No. C.2 / 3.0)
- v. All MOUs / Parent Company Guarantee Deed of Guarantee / Agreement between Bidder and their Parent / Corporate Guarantee by Parent / Ultimate Parent / Holding Company, wherever applicable as per BEC Cl. No. B.1 / 2.5 & 2.6 (Technical) and B.2 / 6.0 (Commercial).
- vi. Bidders should submit RGL Reports in original in physical form.

If Bidder fails to submit original documents with the same content as in the copies submitted in the un-priced bid folder (through e-bidding engine) and in accordance with the bidding document, irrespective of the status / ranking in tender, the bid will be rejected and ONGC may consider to debar the bidder from participating against its future tenders.
