Eligibility Criteria:

- Only foreign passport holders are eligible to apply for the complimentary package.
- Overseas Trade Visitor should be in the home textile or Clothing Accessories import business for at least 3 years.
- Each importing company will be entitled to get above mentioned travel packages for two persons maximum.
- This offer is limited only to the level of Director / Senior Executive / Sourcing Agent and will be on a First-come-First served basis subject to Overseas Trade Visitor eligibility criteria as stated.
- The ticket offered as per eligibility will be a non-endorsable, non-transferable, restricted economy ticket.

PRODUCT PROFILE OF EXHIBITORS :

Home textiles, Made-ups, Silk products, Floor coverings, Real Madras Handkerchiefs, Sarongs / Kailies, Woollen Handlooms, Jute Handlooms, fashion accessories like Stoles, scarves, shawls from various states of India would be displayed at this event.



The guidelines for reimbursement of air fare and hotel accommodation

The air ticket must be purchased by the Overseas Trade Visitor at his/her own cost. The eligible Overseas Trade Visitor will be reimbursed the cost of his/her air ticket (subject to their eligibility as specified above) on the last day of the fair at the fair venue (Fair Secretariat) on submission of the following documents:

- E-Ticket Copy.
- Copy of Invoice of E-Ticket.
- Original onward journey boarding pass.
- One passport size photograph.
- Passport Copy.
- Visa Copy.
- Form No. 1 (To be provided by HEPC during fair days on arrival at the fair venue).
- Feedback Form (To be provided by HEPC during fair days on arrival at the fair venue)

The components for which support shall be provided are complimentary three / two nights hotel stay (only lodging) with complimentary breakfast.

Obligation on the part of the Overseas Trade Visitor :

- The Overseas Trade Visitor shall give a report of the exhibitor they met, products of interest; actual buying done or they intend to place order.
- The Overseas Trade Visitor may be interviewed by the press and media and also attend photo sessions.
- Items other than room tariff, room taxes, breakfast, shall be charged directly by the hotel and payable as per actual consumption by the buyer such as room services, laundry, business center usages etc.
- The Overseas Trade Visitor understands that once they register for coming to India to participate in the event and once Council confirms their participation their details will be circulated to participants.
